

JIM CHALMERS, TREASURER OF AUSTRALIA

**MATRIX OF STATUTORY STANDARDS AGAINST

The context is systemic corruption of Budgetary and Program standards and vicious persecution of LNP professional critic, at national and state levels from mid-2010s ; and a genuine challenge to act in the national interest in his statutory roles.

- His methodology is the Coalition's "gifting" approach which has no options and scenario-testing legitimacy in such key areas as Defence, urban and regional infrastructure and employment generation (ditto they cannot use my Newcastle world-class post-carbon achievements), Health and Education - **in total violation of "Treasury Regs", OECD and World Bank guidelines, and Eddington/Greiner published and accepted then rejected methodologies**
- I will gazump him at every turn as I did to Frydenberg/Kennedy to their complete bewilderment and subsequent Budget manoeuvrings through failed economic, bushfire, corona and climate challenges - because **they have stolen from me and my family, hurt society and economy unnecessarily, and stopped me from supporting Save the Children, Police Legacy, cancer sufferers and their families, and my life-long ambition to honour our "forgotten heroes"**
- The "Unholy Succession" © from Morrison to Albanese has tainted the integrity and competence of the reforming government. Two key portfolios have lacked merit-based assessments of incumbents against alternative appointees, in violation of corporate and public administration values, so far crippling outcomes.

I have to add that the PM's promise to "end the shameful toleration for corruption" which dominated the backroom exclusion of society and experts has been compromised to the point that **only my solution to the deep blood stains can expiate the "foule pestilence of plagiarism"**.

31 Dec 2017 re Kennedy' - The corrupting influences are seen to be, in contradiction to proper standards of professional public service:

- **executive/political fusion**
- **political bias and adhesion**
- **power psychoses**
- **property interests**
- **poor economics, engineering**
- **and community leadership**
- **naïveté**
- **city bias, rural dislike**

Specific exclusions from the whole Budget chain, starting with the Economic Update through the incompetent Business Summit (special webpage on sydneybetrayals.me), also **bring the Parliament into disrepute** – see also following.

THEFT: This has been the topic of vigorous and regular correspondence, with no LNP, ALP or RTBU official willing even open the door or window, the PM having refused to respond to four requests for urgent conciliation. This is explicitly illegal in the following terms.

CRIMINAL

Inequity, waste of resources or public money and reputational damage constitute

“maladministration”: NSW: defined in the Public Interest

Disclosures Act 1994 etc as "conduct that involves action or **inaction** of a serious nature" that is:

contrary to law; or unreasonable, unjust, oppressive or improperly discriminatory; or based wholly or partly on improper motives”

Associated are intimidation & harassment:

ALRC: no general provision under Criminal Code for harassment but “A serious invasion of privacy may often also amount to harassment. Harassment involves deliberate conduct. It may be done maliciously, to cause anxiety or distress or other harm, or it may be done for other purposes. Regardless of the intention, harassment will often cause anxiety or distress. Harassment also restricts the ability of an individual to live a free life.”

Inequity: Chalmers pays Kennedy \$1 million p.a. but refuses to release back to me the money that was stolen to the point I have been homeless since April 2013 and destitute, falling into inevitable ill health to the point of near-death, 10 days of intense hospitalisation, 62 days of antibiotics and 6 months of constant medical support but still experiencing declining health due to malnutrition and extreme hypertension – this potentially an international case study of abuse of Human Rights (below).

Malfeasance, misfeasance and nonfeasance are “corrupt acts” as reflected at individual levels but also societal ones. Corporate studies of “groupthink” point to the loss of “sense of reality” leading to catastrophic failure. Albanese has had such failures but refused to “repair” them.

iA become the greatest example of maladministration in history. My efforts to reform that brought Kennedy’s bile (with other reasons like Turnbull’s ignorance and narcissistic aggression). That bile continues, in defiance of OECD and general accepted protocols for productivity, nation building and “climate change mitigation”.

Inactions:

“Not doing” these and others is arguably gross mal-administration and is done for improper motives by the PM and Chalmers:

- Bushfire risk reduction through 8,000 indigenous rangers, rising risks makes this a certain life-threat
- Budget reform to link with climate, demographic and program changes, reduce waste and corruption in structural terms, and enforce probity and integrity – corruptly suppressed by Kennedy for 8 years now
- Governance improvements especially the National Council which will re-energise Covid performance as the risks are fast rising, savings will be made in hospitals
- Urban transit especially expressnets (such as Bondi/Bright/St Kilda, innerwest, growth areas)
- Local government including “willingness to pay” and innovation districts, links with Newcastle NSIP and climate change mitigation (industry revitalisation)

Waste of resources or public money: failing to consider the “smart politics” manner that would facilitate the essential – unavoidable – national co-operative review of infrastructure to reduce waste, corruption and debt and properly budget for covid, reducing bushfire and flood risks and external costs in hospitals, clinics, medical supplies etc – I have a substantial complaint of maladministration associated with the “National Cabinet” which is a waste of resources and an absence of sensible planning of co-ordinated covid programs, purchasing and community resilience – the PM and Chalmers have suppressed this and all other matters raised here, amounting to very series inaction.

An explicitly malicious and cruel attitude was taken by Baird in 2008 leading to similar actions by his LNP colleagues Berejiklian, both Turnbulls, Morrison, Frydenberg, Kennedy and Gaetjens/Power. This has been documented progressively and contemporaneously on four websites.

PM Albanese and Chalmers knowingly took Kennedy with them into the new government and knowingly extended the same vicious Coalition/Kennedy maltreatment for 151 days as at 20 October.

The intent was to harass me to death and the actuality was just that but for a Hand of God moment in Corowa.

I further allege illegal confinement and loss of contact with my family, partner, domicile city and lifestyle including shelter, transport, recreation and entertainment.

The Criminal Code has conditions regarding total physical restraint. While in Albury Base Hospital medical staff discussed the reasons for my health conditions and advised most strongly that my enforced 6 years in tents constituted dangerous health risks. **The malevolence of LNP and RTBU officials, now extended by ALP officials, is equivalent to “confinement” in my belief; and the PM’s & Treasurer’s denials of my requests to recover my life have been oppressive and worse.**

The PM identified “*the shameful tolerance of corruption*” which is an indicator of bullying and of conspiracy (instead of nation-building’s professional executive contributions adding to better government outcomes). **That tolerance is corrupt in the fullest sense and applies to all parties who maintained their shameful silence in response to my pleases for fairness.**

There are a number of Ministers whose performance would be enhanced by my work, or whose reputation will be damaged by further revelation of suppression, such as

- Indigenous Australians
- Emergency
- Industry
- Climate
- Transport
- Treasury
- Health
- Attorney-General.

More completely, Chalmers has imperilled

- All ministers for not fighting the reasons why “end the shameful tolerance of corruption” has not been expunged
- PM Albanese and Treasurer Chalmers for capricious aspects
- Kennedy in perpetuity
- Also in perpetuity –

- Baird
- Berejiklian
- Turnbulls
- Morrison
- Frydenberg
- Many journalists

Human Rights abuses

ACCC

Determining whether conduct is unconscionable:

- the relative bargaining strength of the parties
- whether any conditions were imposed on the weaker party that were not reasonably necessary to protect the legitimate interests of the stronger party
- whether the weaker party could understand the documentation used
- ...
- ...
- the willingness of the stronger party to negotiate
- the extent to which the parties acted in good faith.

This is not an exhaustive list and it should be noted that the court may also consider any other factor it thinks relevant. [NB relevance is indicative as other discretions are similar.]

The Fair Work Act defines bullying as “repeated unreasonable behaviour towards another person or group which creates a risk to health and safety.”

That behaviour is refusing to discuss or conciliate the false withholding of my assets by governments and especially now PM&C and 14 years of such behaviour by LNP politicians and the RTBU.

Plagiarism as theft is done for illicit gain as with Berejiklian stealing my economy ideas on the Bankstown metro line – reversing Staples’ usual engineering stupidity as well as worth \$4 billion or so given Perrottet has falsified Budget Papers to try to frustrate my legitimate claim. The same applied to the whole of the Greater Sydney Commission’s planning “philosophy” being axial Vs stealing mine being “expressnets / accessibility.

It is also a weapon as with Berejiklian sterilising the CBD and Innerwest transit and congestion package – “the best idea in 100 years” (Loder & Christie). **This was pure evil as well as strangeness as Albanese and Deegan ignored it while pursuing impracticable notions.**
